*Dear Customers,*

We are required to monitor your drinking water for disinfection byproducts (total trihalomethanes (TTHM) and haloacetic acids-five (HAA5) every 90 days from the peak historical month (June). Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During the monitoring period of **January** through **March**, the Rural Franklinton Water did not monitor, did not complete all monitoring, or did not report the results for total trihalomethanes (TTHMs) and haloacetic acids-five (HAA5), and therefore we cannot be sure of the quality of your drinking water during that time.

This violation occurred because of the failure to collect the required samples for total trihalomethanes (TTHMs) and haloacetic acids (HAA5) from the water system's distribution system.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

**We did not report the results** for total trihalomethanes (TTHMs) and haloacetic acids-five (HAA5) at the proper monitoring time, however, necessary action has been taken to prevent this violation from recurring. We have resent our results to DHH for this monitoring period.
